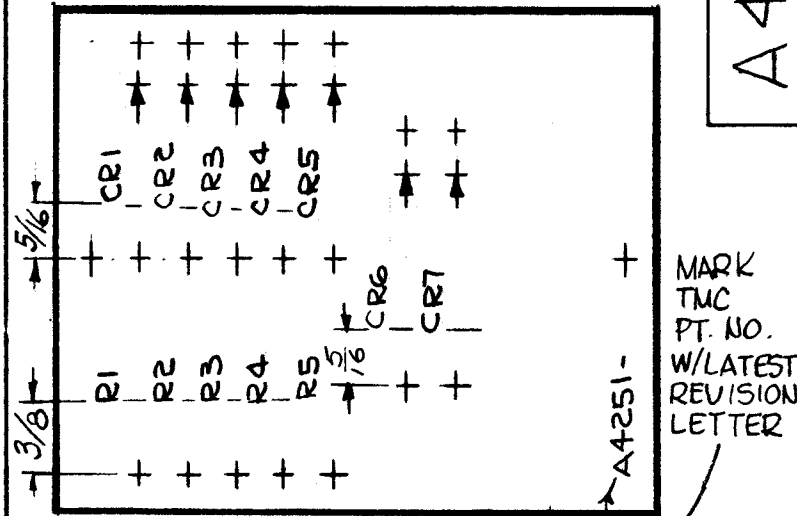

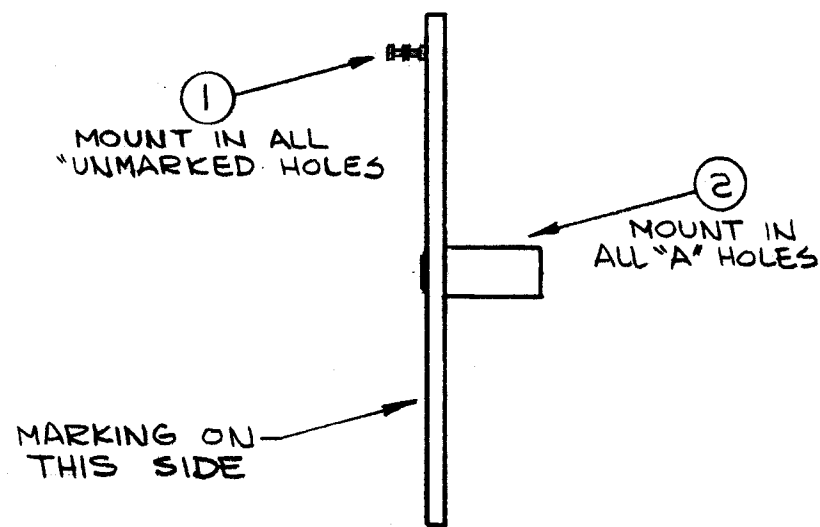

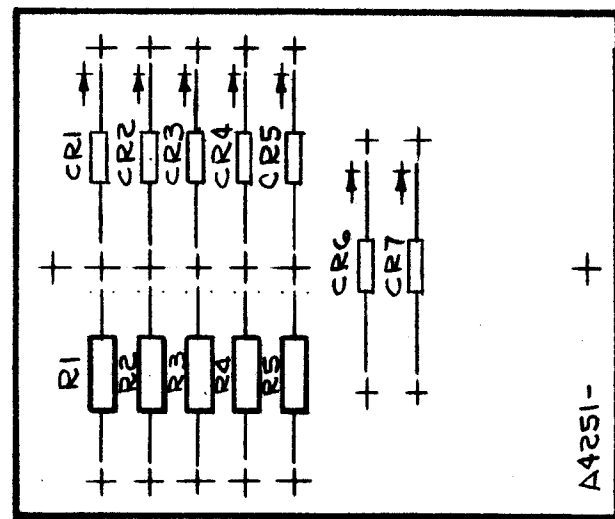


FINISH - S113 FUNGUS RESISTANT VARNISH AFTER LETTERING.
