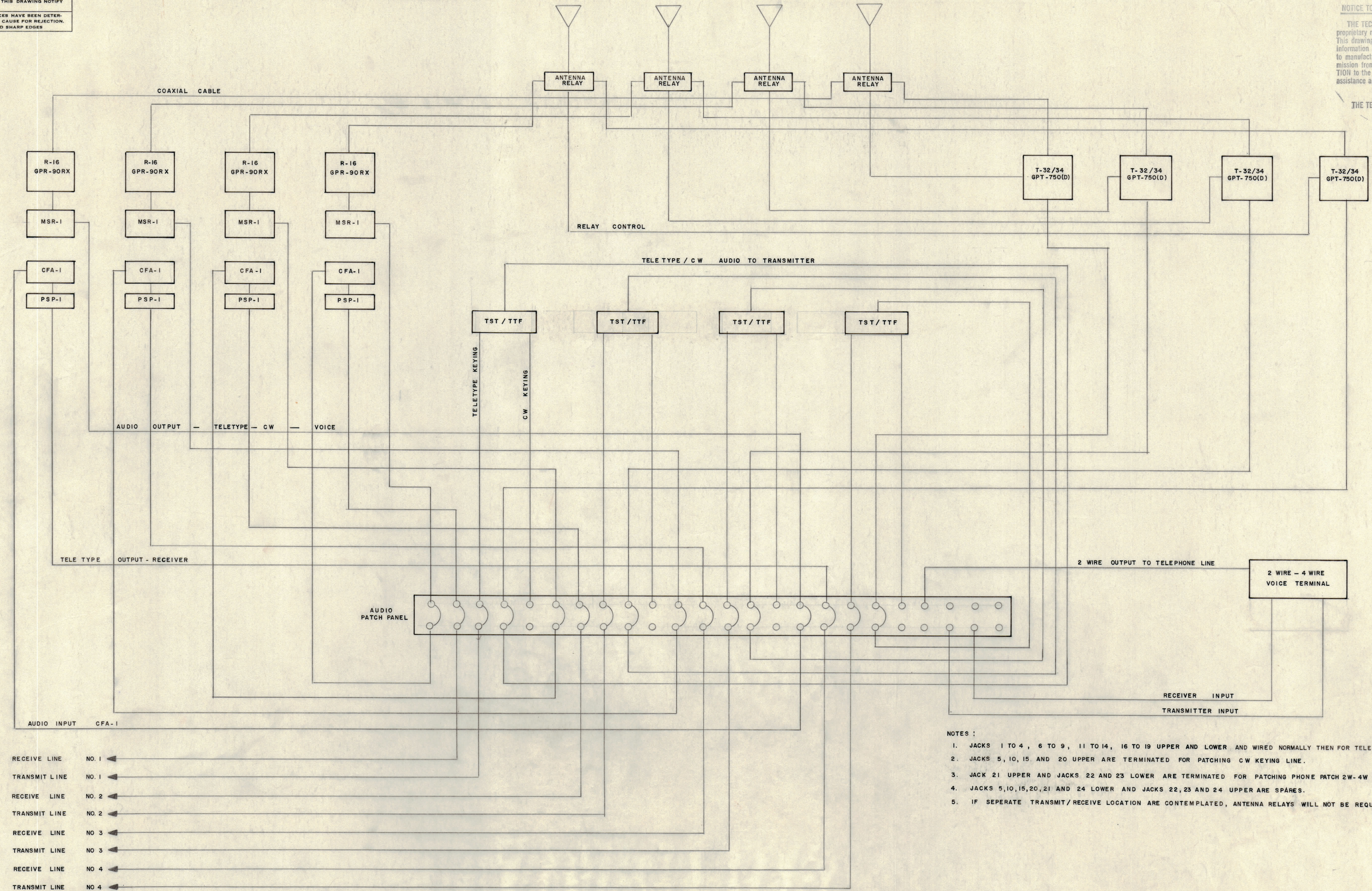

  4. JACKS 5, 10, 15, 20, 21 AND 24 LOWER AND JACKS 22, 23 AND 24 UPPER ARE SPARES.
