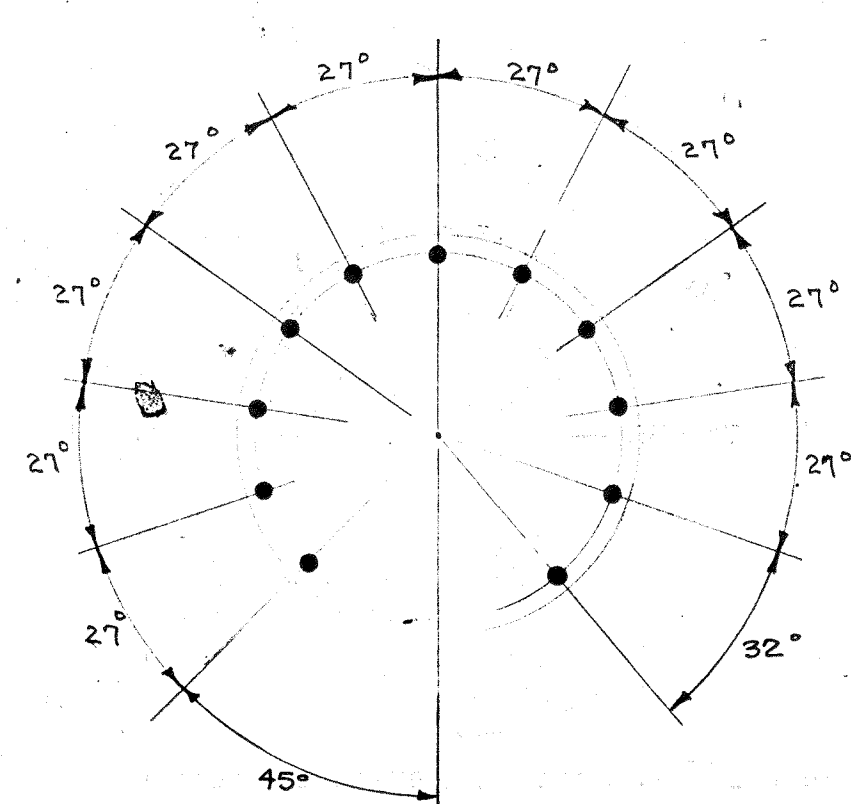
ANGLE DISPLACEMENT METER SW

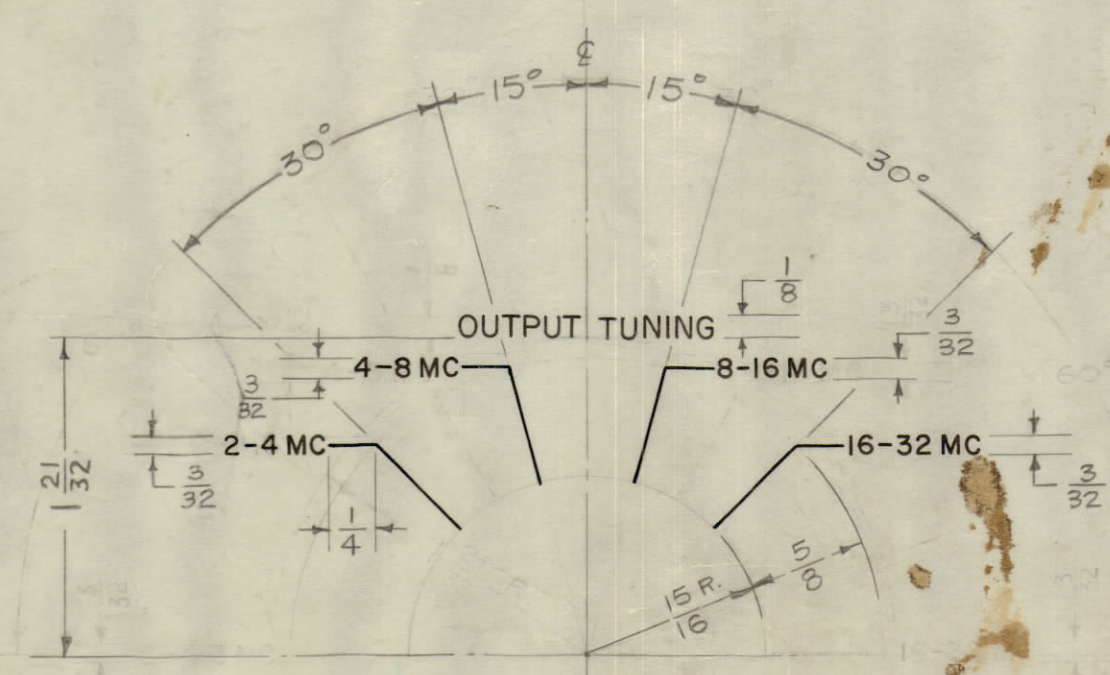

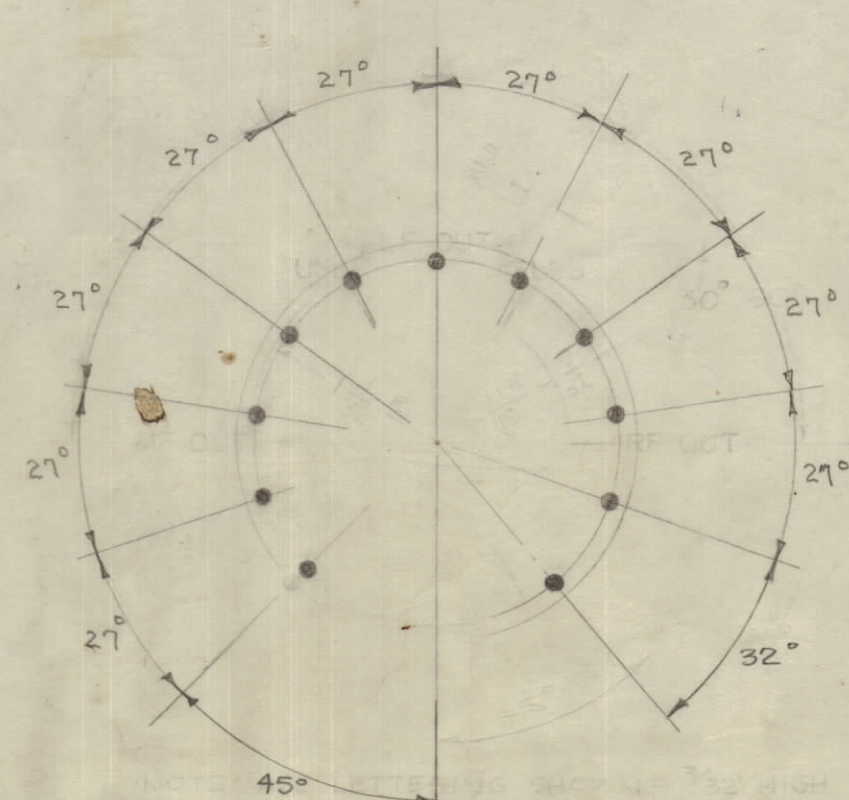
ANGLE DISPLACEMENT METER SW
