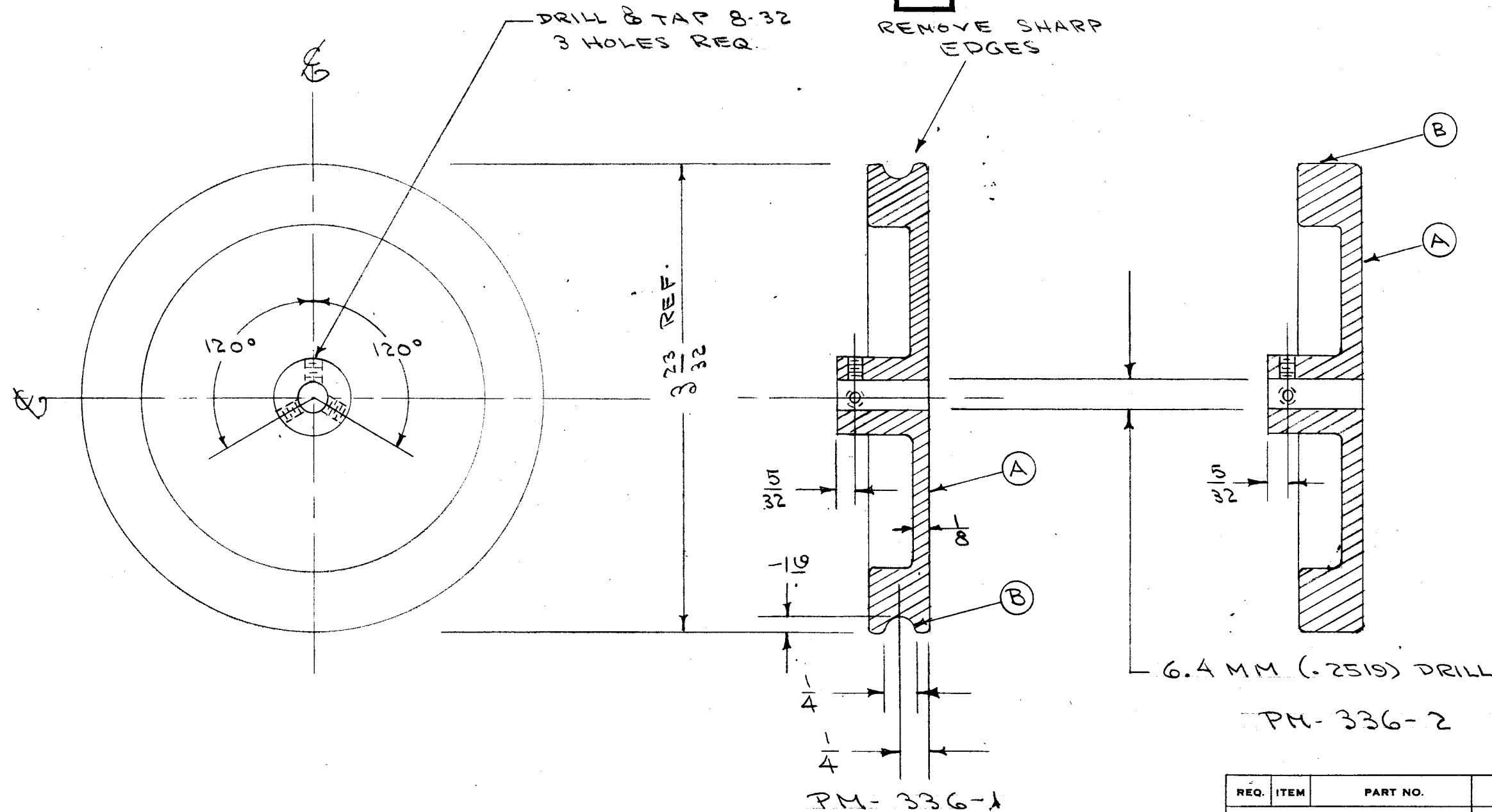
- 1- TRUE SURFACE "A" ON SANDER
