C E R T I F Y :

2. The Certificate of Incorporation was filed in the Office of the Secretary of State on the 29th day of September, 1947.

3. The Certificate of Incorporation is hereby amended, as authorized in subdivision two of Section Thirty Five of the Stock Corporation Law to effect the following amendments:

a) To change the location of its office,

b) To change the address to which the Secretary of State shall mail a copy of process in any action or proceeding against the corporation which may be served upon him,

c) To change the place of meetings of the Board of Directors.

4. Paragraph "FOURTH" of the Certificate of Incorporation which refers to the location of the office of the corporation and designates the address for the mailing of a copy of process against the corporation which may be served upon the Secretary of State is amended to read as follows:

FOURTH:- The office of the corporation shall be located in the Village of Mamaroneck, a duly incorporated Village, County of Westchester, State of New York.
