The capital of the corporation is reduced by the amount of \$75,000 by the elimination of the 750 shares of preferred stock of the par value of \$100 per share previously issued and outstanding which shares have been redeemed. The surplus resulting from such reduction shall be available to be used for any purpose for which surplus may be used.
